## Robinson+Cole Lawyer Receives CAPP 2015 Business Leadership Award

*Litigation lawyer Brian Moran recognized at awards breakfast on November 8*

HARTFORD, CT (November 10, 2015) – [Brian E. Moran](#), a business litigation partner in Robinson+Cole's Stamford office, received the CAPP Business Leadership Award on November 8, 2015, at the Ninth Annual Communion Breakfast for Business Leaders at Fairfield University. The award was conferred by Centesimus Annus Pro Pontifice (CAPP), a lay-led, Vatican-based organization founded by Pope John Paul II in 1993.

Mr. Moran was recognized for his significant contributions to the community through his philanthropic work. In addition to serving as a board member of the Inner City Foundation and previously serving as chairman of United Way of New Canaan and as a board member of the New Canaan Community Foundation, Mr. Moran has championed two major community causes in recent years.

Most recently, working on behalf of the Malta Justice Initiative, Mr. Moran has advocated for criminal justice reform to reduce the size of our prisons and to help ex-offenders reintegrate into their communities. In 2014, he authored the book *The Justice Imperative: How Hyper-Incarceration Has Hijacked the American Dream* (Significance Press), which received the Bridgeport Re-Entry Collaborative's Urdang–Torres Community Impact Award and an Honorable Mention in the Top Ten Black Books of 2014.

In 2003, he founded Success Foundation Inc., which ran an intensive three-week summer study course at Sacred Heart University for low-income ninth graders with college potential called SUCCESS (Students Undertaking College-Career Enhancing Study Skills). In 2006, SUCCESS was awarded a Gold CQIA Innovation Prize by the Connecticut Quality Improvement Award Partnership, Inc.

Mr. Moran focuses his practice on licensing and shareholder disputes, antitrust, and intellectual property matters.
