### [Ransomware Attacks More Frequent and Recovery Efforts Extended in 2020](#)

A new report published by Coveware concludes that companies hit with ransomware attacks spend an average of 16 days recovering from the attack. Think about being offline and unable to do business for 16 business days. It is extremely disruptive and costly. It takes larger organizations longer to recover than smaller ones, and larger organizations are getting hit more frequently with ransomware attacks in 2020 than 2019. California has a privacy law that took effect on January 1, 2020, and it’s not the California Consumer Privacy Act (CCPA). This new privacy law regulates Internet of Things (IoT)-connected devices. [SB 4327](#) was enacted in 2018 and became effective on January 1, 2020. ### [Super Bowl LIV—No Drone Zone](#)

The Federal Aviation Administration (FAA), along with federal, state and local law enforcement agencies, is informing drone operators of the restrictions on drone flights before, during and after Super Bowl LIV on Sunday, February 2nd at Hard Rock Stadium in Miami Gardens, Florida. The FAA expects more than 2,500 additional take-offs and landings and almost 1,300 additional aircraft to be parked at South Florida airports during Super Bowl week. Therefore, Temporary Flight Restrictions (TFRs) and a “No Drone Zone” will limit flights around Hard Rock Stadium. [Read more](#)
