The case was eventually settled. Judge Shea and Chief U.S. District Judge Janet C. Hall of the District of Connecticut both commended the work of Mr. Nault and Ms. Droney, thanking them for their willingness to accept the case as well as for their outstanding advocacy.

As a central part of the Robinson+Cole culture, the Community Service Award recognizes efforts to build strong, sustainable partnerships within local communities and to promote service, community commitment, and civic responsibility. The 2016 award was presented to both <a href="Keisha S. Palmer">Keisha S. Palmer</a> and <a href="Jacqueline Pennino Scheib">Jacqueline Pennino Scheib</a> for their part in establishing and sustaining the University of Connecticut School of Law/Robinson+Cole Summer Law Institute.
